ARTICLE I - NAME

The name of the corporation is SkyRanch Flight Association, an Arizona nonprofit corporation.

ARTICLE II - PURPOSE

The corporation shall be a nonprofit corporation under Arizona Revised Statutes, \$ 10-1001, et seq; and the purposes for which the corporation is organized include conducting any or all lawful affairs for which nonprofit corporations may be amended from time to time.

ARTICLE III - INITIAL BUSINESS

No shares of stock representing an ownership interest shall be issued.

ARTICLE VI - PLACE OF BUSINESS
